



# Overview

According to *Investment Report 2020-2021: Investing in Industry 4.0* issued in September 2021, despite a drop from a record high in 2019 due to the Covid-19 pandemic, ASEAN remains an attractive investment destination, with its share of global foreign direct investment (FDI) rising from 11.9% in 2019 to 13.7% in 2020. Specifically, Cambodia attracted all-time high FDI inflows at \$3.6 billion in 2019, a figure it maintained in 2020. Vietnam, on the other hand, enjoyed resilient and stable FDI inflows at \$16 billion in 2020. Investment from ASEAN topped the list of FDI inflows into Vietnam, with companies from Singapore accounting for more than 40% of the inflows in 2020.
